Since 1950 my family has been located in Hesperia, California. My Grandparents coming from Iowa, Texas & Utah. We've done business as Marr Pipeline & Drilling Co., Great Western Publishing Co., Century 21 Jensen & Jensen, Century 21 Rose Realty, Rose Enterprise, Key West International Real Estate Investments, & Key West Engineering. Our family has always been self-employed, involved in road and home construction, advertising, newspaper publishing, restaurants, real estate and mining. Our family owns 560 acres of prime mining land in Crescent Valley Nevada right between Barrick Cortez mine and Newmont mining operations. I currently hold a California Real Estate Brokers License and I am the Legislative Advisor to the Mining & Minerals Advisory Council (MMAC).

I have retired from the Military after 23 years in the US Air Force Reserves, having started out in the 163rd Air National Guard as a Jet Mechanic and cross trained into the Air Force Disaster Response Force. I have traveled the world serving as a Nuclear, Biological, Chemical (NBC) Defensive Warfare Specialist. I retired with the rank of MSgt and over the years been assigned to March Air Force Base, McClellan AFB, HQ Pacific Air Forces (PACAF). I have spent the last 30 years in Real Estate. Additionally I am the Former Mayor to the City of Hesperia & past Congressional Candidate, which has provided me with a constant exposure to all aspects City, County, State, & Federal Government. This environment means that I have to deal with City Councils, County Boards of Supervisors, State Assembly & Senate Offices as well as the U.S. Congress, Senate and the associated Committees. In order to be prepared to deal with these agencies it has paid me to be well grounded Constitutionally when addressing Planning Commissions, Building & Safety, Engineering Public Works, the Veteran's Administration, Department of Defense, Environmental Agencies, Department of Interior, Bureau of Land Management (BLM), Dept. of Forestry, Army Corp of Engineers, Cal-Trans, Aviation, etc. I understand Environmental Impact Laws and how they relate to Flora and Fauna, to include Agency over-reach in accordance with Congressional Over-sight.

Further my understanding of commercial lending is absolutely crucial in accordance with advocating the need for Financial Certainty, required by banks for mining operations, or any other project. As an NBC Instructor, I have trained thousands of troops in initial and refresher courses in NBC Defensive Warfare and completed Hazardous Materials Awareness & Operations Courses certified by the State of California. I am a trained Jet Mechanic and "Jet Noise is the Sound of Freedom".

With this diverse background I bring the ability to simultaneously handle multi-faceted & complicated events, that include accountability and the rule of law where National Security are concerned.
