

ORGANIZE AND MODERNIZE YOUR MINING DISTRICT TO POSSIBLY HAVE A MODERN DAY FEDERAL RECOGNITION

This is an example on how to organize your MMAC Assisted Mining District.

WARNING

IF YOU SET UP, FILE AND OPERATE YOUR MINING DISTRICT WRONG, YOU POSSIBLY MAY KILL ANY CHANCE OF YOUR MINING DISTRICT TO BE FEDERALLY RECOGNIZED IN A MODERN DAY SENSE, TO EXIST IN CURRENT DAYS AND YOU MAY KILL THE CHANCE FOR ANYONE ELSE IN THAT MINING DISTRICT TO OPERATE UNDER THAT MINING DISTRICT. THIS MAY OPEN YOU UP FOR A LAWSUIT.

**Please review and do your own due-diligence
too make sure what MMAC is telling you is correct for your Mining District**

YOU SHOULD NOT START A NEW MINING DISTRICT

- 1) ICMJ Prospecting and Mining Journal, needs to check that the person placing the notice of election for the Mining District (“MD”) has;
 - a) Proof of having a MMAC Gold membership (to be MMAC assisted)
 - b) Has payment into the ICMJ
 - c) Has legal proof of the MD historical name, date of origin if possible and location
 - d) Then it may be listed in the ICMJ.

- 2) Instructions for the preliminary setting up of your MD will be found in your MD membership package. Why has this changed?
 - a) Because non-MMAC member miners that are uninformed or listening to the uninformed, have started setting up or have set up their mining district(s) incorrectly
 - b) Have become confrontational with agencies
 - c) Have not availed themselves to the proper process and
 - d) Are not consistent with the mission of MMAC or the law.

- 3) When all the above is completed, e-mail the documentation to MMAC at: miningdistricts@mmacusa.org so that MMAC can first;
 - a) Verify your mining district
 - b) Possibly certify your mining district
 - c) Then to see if it may qualify for modern federal recognition as a legitimate Mining District and not a club or non-profit.

(Example: There are many Native American tribes in the same position. They are legitimate tribes, not federally recognized.)
